Safeguarding Notices:

challenging term-time holiday and persistent absence

After a meeting with our Local Authority Education Engagement Officer, I felt it worth reiterating some points to families. In particular, some of the context around challenging term-time holiday absences and challenging persistent absence. Head teachers have discretion to grant leave during school term time, but this is not an automatic entitlement. The law governing such leave of absences was tightened up from September 2013. Under current regulations, head teachers may not grant leave of absence during termtime unless there are exceptional circumstances. These circumstances are explained to families on our request forms, as are the potential consequences of taking such holiday. The local arrangements in Somerset are that penalty notices will be issued via the local authority on behalf of all educational settings in respect of pupils who are of statutory school age.

- Term-time holiday requests: Penalty notices can be issued to each parent (or person with parental responsibility) and for each child when it is deemed that an offence has been committed. This protocol ensures that penalty notices are administered consistently and fairly across the local authority. The Education Engagement Service fulfils this duty on behalf of the Local Authority.
- Applications for term-time leave must be made in advance and in writing. Failure to do so will result in the resulting absences being unauthorised.

When an application for term-time leave is declined, any resulting absences will be unauthorised. Unauthorised absence relating to term-time leave being taken will be sent to the Local Authority for consideration of a Penalty Notice when 10 or more consecutive sessions are unauthorised.

- **Ten absences = 1 school week.** If it is found that a family has been given warning of any consequence (as on the back of our term-time request form), then this is uploaded to the Local Authority online system and they will be the body to issue the penalty. The fixed amount for this Penalty Notice is £120, which must be paid within 28 days to avoid prosecution. A reduced rate of £60 is payable if payment is made within 21 days. Payments cannot be paid in instalments Step parents can be fined, also. The school upload this information on the return of the pupil to school.
- **Tackling persistent absence**: we work tirelessly with families to ensure that attendance is communicated clearly and find solutions to any persistent problems for individuals. In school, we will send out a letter

www.bathand wells.org.uk notifying you that your child has fallen into a category whereby they have missed at least 10% of their school days, so far. This can sound a lot, but only 3 or more days per half term makes a child persistently absent. We are sensitive to families having very different needs and this is a completely different route to the term-time pathway. Many families do not realise they have fallen into this bracket until they are presented with the evidence and we check to see if there are any patterns. For example, our Management Information System can track whether a pupil has a pattern of every Friday off, or doesn't attend on a Monday. All these factors can be unpicked and worked on together to improve attendance. Only when all avenues have been exhausted would the Local Authority look to procced further with penalties. Working together is always our aim!

In conclusion, please do be aware of the information on the back of the term-time forms and understand the consequences that the govt and Local Authority have put in place. I am held account, by Governors and by Ofsted, on the approach we take and what measure we put in place to encourage attendance at school. **Supporting attendance** is something that we do to the best of our abilities, but we can always improve and outside agencies are a huge part of this vital offer.

Emotionally Based School Avoidance (EBSA) is a term used to describe children and young people (CYP) who experience challenges in attending school due to negative feelings (such as anxiety). EBSA is commonly associated with emotional and physical distress, and a reluctance to attend school, which can lead to reduced attendance and further anxiety regarding school.
